# **KIDOZ INC. - CORPORATE HISTORY**

- 1. Effective September 30, 2004, the Company was incorporated, pursuant to the *Companies Act* (Anguilla) under the name, "Bingo.com Inc.", under recognition number 1008152 (Certificate of Incorporation attached hereto as Schedule A-1).
- 2. Effective October 5, 2004, the Company filed Articles of Amendment with the Anguilla Registrar of Companies, changing its name from "Bingo.com Inc." to "Bingo.com, Ltd." (Certificate of Incorporation on Change of Name attached hereto as Schedule A-2).
- 3. Effective November 4, 2004, the Company continued from the *Companies Act* (Anguilla) to the *International Business Companies Act* (Anguilla), under its name, "Bingo.com, Ltd." under recognition number 2043437 (Certificate of Continuation attached hereto as Schedule A-3).
- 4. Effective April 6, 2005, the Company merged with its parent company, "Bingo.com Inc", a Florida Company, with the Company surviving the merger under the name, "Bingo.com, Ltd.", pursuant to the *International Business Companies Act* (Anguilla), retaining its recognition number 2043437 (Certificate of Merger attached hereto as Schedule A-4).
- 5. Effective January 22, 2015, the Company filed Articles of Amendment with the Anguilla Registrar of Companies, changing its name from "Bingo.com, Ltd." to "Shoal Games Ltd" (Certificate of incorporation on Change of Name attached hereto as Schedule A-5).
- 6. Effective April 9, 2019, the Company filed Articles of Amendment with the Anguilla Registrar of Companies, changing its name from "Shoal Games Ltd" to "Kidoz Inc." (Certificate of Incorporation on Change of Name attached hereto as Schedule A-6).
- 7. Effective December 9, 2022, the Company merged with its subsidiary, Coral Reef Marketing Inc., an Anguilla Company (recognition number 2116221), surviving the merger under the name, "Kidoz Inc.", retaining its recognition number 2043437 (Certificate of Amendment attached hereto as Schedule A-7).

# **SCHEDULE B**

# **OTHER PROVISIONS**

The directors of the Corporation may appoint one or more directors of the Corporation but the total number of directors so appointed may not exceed one third of the number of directors elected at the previous annual meeting of shareholders of the Corporation. Any directors of the Corporation appointed pursuant to the previous sentence shall hold office for a term expiring not later than the close of the next annual meeting of shareholders.
